CSA Philosophy

Community Supported Agriculture (CSA) is a partnership between consumers and farmers. The philosophy is one of mutual support, respect and sharing of the risks and benefits of food production. By joining, you, as a "member" receive a portion of the fruit grown on our family owned farm.

For the Farmers: The money that you pledge to us, allows us to invest in pruning, materials and labor that are needed in the spring. Your support is what allows us to do what we love and feed our community.

For You: The Consumer, Supporter, Friend: You receive what we have seasonally available on our farm in allotted amounts, reflective of their value. We try our best to distribute an array of high quality varieties at a great value, based on the harvest and thus, the weather. You can always ask questions along the way and we hope that you take a chance to get to know the people that are growing your food by doing so!

How our CSA Works

Traditionally, CSAs have their members take a box of pre-packed produce, filled with whatever the farm has in abundance. While this option provides for a faster pickup, members lose the ability to choose. Instead, we decided to have a Farmers Market style distribution. Here's the list of our CSA process:

1. Show up to your site on time, bringing a bag and sense of adventure!
2. Check in with the Farmer in Charge by telling us your last name.
3. Each type of apple (an "item") has a sign telling you how many pieces of that fruit you can take.
4. Pick out the fruit you want and take only what you're allotted for your share size.
5. Done! Go home and enjoy your freshly harvested fruit!

We are not responsible for any arrangements made between you and anyone that you potentially split a share with at the CSA. Please tell us about any issues with quality while at CSA.

Refunds/Cancellations

All sales are final

All sales are final. Credit card payment must be in full to receive any items from our stand. Cash will be accepted upon receipt. All items are subject to availability and we reserve the right to cancel your order (and hope to fulfill it later, if the situation allows). Sales are final. These shares are absolutely non-refundable.

Payment

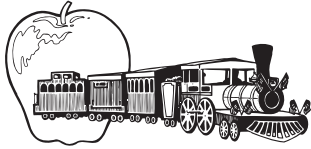
Signing up for a share reserves that share, while payment confirms your membership. Payment must be made in full by August 1st of the current season for shares cash or credit card are accepted. We do not store any of your personal financial information on our website.

Changing Pick-Up Sites

You are required to choose one CSA site and are expected to stay at that site for the duration of the CSA. Before the start of CSA, please email us (csa@tennesfarms.com) to switch your site. Sites/times will be finalized in June of the upcoming season for fall shares. After CSA has begun: in certain cases we can switch your site. Please contact us at least two weeks before switching. Once you have switched to another site we ask you stay there for the duration of CSA. Example: some members choose to switch locations during September/October, when their kids return to school and their schedule changes.

Communication

Newsletters/Email: We hope to send out a newsletter the week you are expected to pick up your share. It behooves you to read these communications to be better informed. You are welcome to unsubscribe at any time. If you choose to unsubscribe, you may miss important information about add-on shares, or unexpected site changes.
